- 4. Business arising from minutes: a) Councillor Florent reported that from now on all "buildings" will now be referred to as "facilities". There has been an increase in the rates of rentals of all facilities to non-residents of the Township of South Algonquin. It was also discussed that the Smart Serve rules, when running a bar, must be adhered to as well as the rules of the Township are even stricter and must be followed as well. Councillor Florent discussed some vandalism that was discovered at the rink building, where screens were cut, and the boards surrounding the rink surface, where graffiti was found. The playground at J.R. Booth Park will be installed mid-June. The indoor curling equipment has been ordered. b) Reports: i) Easter Party: was well attended with approximately 50 people. ii) Trivia Night: was very well attended with 96 players and raised \$1427.00 for the SFMHF. iii) Spring Sell Your Wares: we had 13 tables and had a profit of \$520.55. iv) Brenda Hildebrandt: the funeral lunch for Opal Wright was on May 8<sup>th</sup>. v) Rosemary Shalla: turned in \$143.00 for the last of the winter rink canteen money for 2018-19.
