5. PUBLIC MEETING: ZONING BY-LAW AMENDMENT ZBA2020-02

A public meeting was held pursuant to provisions of Section 34 of the Planning Act for Zoning By-Law Amendment ZBA2020-02 for lands locally known as 903 McRae Hay Lake Road.

The Zoning By-Law Amendment was a condition for provisional consent.

A Planning Report was provided in the package and T. Cannon, Planning & Building

Administrator provided a brief explanation of the proposed amendment;

Currently the lands are zoned Tourist Commercial Zone Exception Two (C4-2).

The Zoning By-Law Amendment will rezone the proposed retained lands to Tourist Commercial Zone Exception Three (C4-3) to recognize the existing commercial use and an existing accessory structure within the minimum interior side yard and reduce the minimum lot area.

The proposed severed lands will be rezoned to Tourist Commercial Zone Exception Four (C4-4) to recognize the existing commercial use and reduce the minimum lot area.

Mr. Howe, Solicitor for the applicant provided comments that included reasoning for the minimum interior yard provision.

No further comments from the public were received.

The By-Law to amend Zoning By-Law 2017-527 is included in the By-Law portion of the package.

-Received information yesterday pertaining to the roll out of the Covid-19 vaccine. Jim Etmanski and Glory Peplinskie represent South Algonquin at the Barry's Bay & Area Covid Vaccine Planning Committee. Health Care workers have been provided the vaccine. A preliminary list of Fire Dept. members and others that are eligible, have been given to reserve vaccines. After that those aged eighty and over will be eligible. Community halls in Whitney and Madawaska will be utilized; the Team may be looking for helpers. Clinics will be by appointment only.

- -Verified Health Unit report that South Algonquin is included in the count of Covid cases of Barry's Bay and area. Local people are still using the rinks. We are slowly allowing people to rent halls, following new protocols.
- -Scheduled Economic Development meeting for March 17th following the Committee of Adjustment meeting.
- -Scheduled Emergency Services meeting and Human Resources/Administration/Public Relations meeting for March 25th.
- -Council to forward any comments pertaining to the wayfinding maps to H. Hayes soon.

Public Works/Operations

Works Superintendent D. Gatley verbally reported:

- The recent warm weather has caused a rather significant leak at the EMS building in Whitney. Investigation revealed construction deficiencies in the roof area above the Fire meeting room. Performed remedial repairs but it will require reassessment once the snow has melted.
- -The gazebo in Whitney is another potential project that requires a priority condition assessment.
- -Completed McCauley Lake Rd. brushing operation. There is a logger currently in the area that could remove poplar trees, net zero cost to the township as the timber is marketable; consensus of council was to go ahead.
- -There are three UV systems that are no longer being used that could be sold as surplus. Consensus of council was to sell as surplus.
- -Bulk snow removal operation currently happening; benching of snow banks, sight lines at corners.
- -Looking at putting half load limits on next week; have been in touch with loggers that have operations going on.
- -Have regular contact with the engineers working on the dam job who have advised that half of the spill way will be ready by freshet. All of the chutes are operational and they are on track.
- -Discussion regarding marking hibachis at Galeairy Lake Memorial Park to make them visible for snowmobilers.
