General Information to Bidders:

- (a) The Township tender form must be used.
- (b) Tenders will be accepted at the Township of South Algonquin Municipal Office until **Wednesday, June 22, 2022 at 3:00 p.m.**
- (c) Submissions sent by facsimile **WILL NOT BE ACCEPTED.**
- (d) Lowest or any tender will not necessarily be accepted.
- (e) Payment shall be made within thirty (30) days following invoice.
- (f) The contractor shall supply all labour and equipment required to complete the contract.
- (g) The Tenderer's H.S.T. Registration Number must accompany the bid.
- (h) Contractor to supply proof of Worker's Compensation and \$5,000,000 liability insurance.
- (i) All operations shall comply with the Health and Safety Act and the Highway Traffic Act.
- (j) Any costs incurred due to charges being laid against the contractor under any Provincial Acts and or Regulations during the performance of this contract shall be the sole responsibility of the contractor.
- (k) Bulk Course Highway Salt will be supplied by the Municipality.
- (l) The Township will require five (5) days notice of the projected start date.
- (m) An approximate quantity of 2,000 tonnes of Winter Sand will be supplied to the Public Works Yard located at 24808 Hwy. 60, Madawaska where it will be mixed and placed in the Sand Dome to capacity.
- (n) Winter Sand shall be mixed at 3% to 5% salt to sand by the contractor.
- (o) Winter Sand material should meet the requirements of the OPSS MUNI 1004 guidelines and a minimum of one satisfactory sample result by a CCIL certified lab must be supplied.
- (p) Material must be conveyor stockpiled.
- (q) Material weighing devices must be annually tested and approved for accuracy.
