TAKE NOTICE

That the Corporation of the Township of South Algonquin is in receipt of an application for Consent (Lot Addition) under Section 53 of the *Planning Act of Ontario, R.S.O. 1990, c.P.13*, as amended, for lands legally described as AIRY CON 5 PT PART LOT 7 REM;PCL 19108 NIP and locally known as 40 Kenny Road. The subject lands are located within the geographic Township of Airy.

PLEASE NOTE that the Corporation of the Township of South Algonquin will be holding an in-person and virtual public hearing under Section 53 of the *Planning Act, R.S.O. 1990, as amended,* to inform the public of the proposed consent.

PURPOSE AND EFFECT OF THE PROPOSED APPLICATION

The application proposes a consent (lot addition) to add approximately 0.45 hectares (1.1 acres) from 40 Kenny Road and add these lands to CON 5 PT LOT 7 RP36R10514; PART 1 PCL 29014 NIP; TOGETHER WITH R-O-W, locally known as 19 Avery Lane. Resulting in the Retained lands having a lot area of approximately 1.83 hectares (4.5 acres) and a lot frontage of approximately 25.4 meters on Paradise Road and 139.6 meters on Kenny Road. The lot being added to will have a lot area of approximately 1.46 hectares (3.63 acres) and a lot frontage of approximately 149 metres on Paradise Road.




