TAKE NOTICE that the Corporation of the Township of South Algonquin has received an application under Section 45 of the *Planning Act, R.S.O. 1990, as amended,* for minor variance/permission for the subject lands locally known as 123B Woodland Lane. The subject lands are located within the geographic Township of Lyell and are located adjacent to Lyell Lake (also known as Cross Lake).

PURPOSE AND EFFECT OF THE PROPOSED APPLICATION

The purpose of the application is to request permission under Section 45 of the Planning Act to construct a two-storey detached garage with second-floor living space (guest rooms). The property is zoned Shoreline Residential (SR) in the Comprehensive Zoning By-Law and a variance is required to Section 4.1.10 to permit a two-storey detached garage with human habitation whereas a one and one-half storey detached garage with human habitation is permitted.
